### Definitions:

1. Here and in the following the term “Licensor” refers to Lijun Zhang at the above address.
2. JAMIP (Jilin Artificial-intelligence aided Materials-design Integrated Package) is an open-source integrated infrastructure designed for computational materials informatics, which exploits intelligent power of artificial intelligence algorithms in massive materials data from high-throughput calculations to discover new materials, functionalities, principles, etc. It is developed by Prof. Lijun Zhang Research Group, Jilin University, China, and is protected by the Copyright Protection Center of China with the registration No. 2017SR514752 and 2021SR0349238.
3. Here and in the following the term “the software” refers to the JAMIP code and all other documentation, scripts, and ancillary materials.

### Mandatory Terms and Conditions:

I acquire a non-exclusive academic license for the use of the JAMIP Package, and will adhere to the following conditions upon receipt of the software:

1. All title, ownership, and rights to the software or to copies of it remain with the licensor, irrespective of the ownership of the media on which the software resides. I will keep intact all copyright notices.
2. I will not supply a copy of the software or of any part of it to anyone for any reason whatsoever. I will refer any request for copies of the software to the licensor.
